The Meeting of the Governing Body of AITAM, Tekkali held on 23rd January, 2021 Online(google meet) at 11.00 AM.

Prof. D. Nageswara Rao, Chairman welcomed all the members.

Prof. A.S. Srinivasa Rao, Principal presented a detailed PPT on overall progress of the college.

During the presentation of the PPT, the members **suggested the following**:

- Members appreciated the online classes and off line examination system in this COVID Pandemic situation and suggested to improve R&D activities by introducing some more incentives to faculty.
- Try for more Collaborations with Industry and introduce four to six months training to students in Industry.
- Focus on Artificial Intelligence as Interdisciplinary programme to both faculty and students and train them accordingly.
- Improve Consultancy Services in each Department.

The following decisions (agenda wise) were taken after detailed discussions among the members in the meeting:

1. Confirmation of the minutes of the previous meeting of the Governing Body and Action Taken Report.

Since no further comments have been received on the minutes of the previous meeting held on 25th Jan, 2020 of the GoverningBody, the same would stand confirmed.

a. Attendance particulars of the students in the last semester, viz., condonation and detention details.

- For improvement of 1st year results, organise tutorials, Counselling and Extra Classes if neccessary.
- Senior faculty (Professors) may take 1st Year classes to motivate students in I year itself.
- If Programming in "C" subject is taught by the other Branch faculty, the student may not pay interest on that subject. If the same branch faculty will teach that programming subject then the student shall pay interest in that subject. Hence Suggested that Better allocate this subject to same branch faculty.

ATR

- We could not organise tutorials, counselling and extra classes because of COVID 19.
- Senior faculty members are taking 1st year classes as per expertise and industry requirements.
- C' subject is being taught by CSE branch faculty only.

b. Malpractice cases in examination conducted during the previous semester.

BoG appreciated the Director, Principal, Faculty and Exam. cell for reduced cases of malpractice in the previous academic year to 6. However, they have suggested to reduce further to zero.

We counselled the students about dos and don'ts on examination and malpractices. We displayed the punishments of malpractices in all notice boards.

c. Details of placement of the outgoing students.

Members appreciated the Director, TPCell for their continuous efforts in improving the placement and suggested to take appropriate steps to increase the placement activities. Upcoming 3 months are very important to take necessary steps and invite more MNCs to our college for Campus recruitment.

- Extra Placement training activities were introduced in III-I & III-II semesters.
- Identified coding related subjects and introduced Interdisciplinary Electives.

d. Discussion and finalization of AR18 - III B.Tech Syllabus.

- BoG suggested to avoid fractions 0.5 in credits for which give one credit for 2 lab periods. Some of the subject pass credits are 1.5 points. Round off it to 1 or 2, It can be integrate with Theory & Labs.
- Observed that there are more subjects in one semester, hence suggested to share the subjects for all semesters to avoid over Burden in any semester.

BoG recommended to implement from AR20 Regulations onwards.

 Revise the syllabus of all branches in the presence of Dr. D. Nageswara Rao, Chairman.

All suggestions were included in AR20 regulations.

e. Approval of Minimum credits for the Award of degree for rejoining students after detention.

When a student is detained for lack of Credits / Shortage of attendance, he/she may be re-admitted into the same semester / year in which he/she has been detained. However, the total credits of Academic Regulations under which he/she was first admitted shall continues to be applicable to him/her but he/she must be re-join in current Academic Regulations and study the subjects of equivalence which will be approved by BOS and Academic Council (Case to Case Basis if necessary)

If no equivalence subject in Current Regulations in which he/she joined, then they have to go for MOOCs Course for Extra Credits.

Minimum credits to be secured for Award of degree in AR16 regulations is 180 & in AR18 it is 160.

Members Welcomed the Introduction of B.Tech(Hons) in the College. However the Criteria should be as follows:

- a) Minimum CGPA required for B.Tech (Hons) is 8.0 No failure in any semester any subject up to II-II semester and continue up to IV-II semester (Not more than 15% Students out of total will get B.Tech (Hons) degree for every Out going Batch).
- b) 20 Extra Credits as proposed by AICTE will get through online courses / Practical Learning preferably in Advance courses which are to be Approved by BOS Members and Academic Council.
- c) All these courses are to be introduced in 2/2, 3/1,3/2, & 4/1 Semesters.
